## Paul Viviano

## President & CEO of Children's Hospital Los Angeles 2021 Vision & Excellence in Healthcare Leadership Award Recipient

Paul S. Viviano is a health care leader and a prominent national voice and advocate for child health. For more than three decades, he has directed academic, nonprofit, and for-profit health care organizations that have delivered excellence in clinical care, research and diagnostics.

Paul joined Children's Hospital Los Angeles as President and Chief Executive Officer in 2015 and serves as a member of the institution's Board of Directors and as a member of the Board of Trustees. Previous to serving as President and Chief Executive Officer of CHLA, Paul served as the CEO and Associate Vice Chancellor of the UC San Diego Health System, an institution noted for its leadership in medical research and patient care.

He has also served as the President and Chief Executive Officer of University of Southern California (USC) University Hospital and USC/ Norris Cancer Hospital and held various Chief Executive Officer roles within the St. Joseph Health System, ultimately serving as the parent organization's President and Chief Operating Officer. He served as Chairman of the Board and CEO of Alliance HealthCare Services, the nation's largest provider of outpatient diagnostic imaging services and radiation oncology services, for 10 years.

As part of his advocacy in support of child health, he serves as the Chair of the Board of Directors of the California Children's Hospital Association and as the Co-chair of the National Children's Hospital Association CEO Advisory Council, two organizations committed to protecting and preserving acute and specialty health care for children. He also serves as a member of the Public Policy Committee for the national Children's Hospital Association.

Additionally, he serves as the Chair of the Board of Trustees of Loyola Marymount University and serves as a member of the Board of the UCLA Health Policy Management Alumni Association.

## Paul Torrens, MD

## Professor Emeritus of Health Policy and Management and Founder of the Paul Torrens Health Forum at UCLA 2021 Lifetime Achievement Award

Dr. Paul Torrens is Professor Emeritus of Health Policy and Management and founder of the Paul Torrens Health Forum at UCLA. In his more than 40 years at the Fielding School, Dr. Torrens has patiently guided, mentored and advised generations of students, helping many shape distinguished careers in public health. A physician by training, he had a long career in both healthcare management and policy. As a healthcare executive, Dr. Torrens held numerous executive positions in hospitals and health care organizations and served

on the governing boards of Blue Shield of California and PacifiCare Behavioral Health of California. In the health policy arena, he served in a wide variety of advisory and consulting capacities to governmental and nongovernmental organizations in the United States and in 18 foreign countries.

Thanks to his vision and leadership, the Paul Torrens Health Forum is a premier source of discovery and conversation about the prevailing public health issues of the day. It is a fitting legacy for a man who has done so much for so many.
